- 3. Each application requires one key contact person who we will liaise with.
- 4. For the Partnering with Councils award, the council must be aware and/or part of the submission. Please provide evidence of this.

  - b. Meaningful partnerships and/or engagement with any other key stakeholders (including community members)
  - c. Any cultural or environmental considerations that were incorporated in the work

- 3. How this strengthened relationship has led (or will lead) to positive outcomes for the community
- 4. Evidence that the council is aware of and/or part of this submission
- 5. Any other key considerations that were part of this mahi, including but not limited to:
  - a. A genuine commitment to te ao Māori principles
  - b. Meaningful partnerships and/or engagement with any other key stakeholders (including community members)
  - c. Any cultural or environmental considerations that were incorporated in the work
